CITY OF NEWCASTLE UPON TYNE TRAFFIC REGULATION (CONSOLIDATION) ORDER 2009 (ST PETERS BASIN AREA VARIATION) ORDER 2018

- 1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 ("the 2009 Order"). Note the Council are in the process of making a new Consolidation Order ("the new Order"). If the new Order is made before the proposed Variation Order, then the proposed Variation Order will become an amendment to the new Order.
- 2. The effect of the proposed Order is to -
 - (a) introduce a no waiting at any time restriction (double yellow lines) on the following lengths of road -
 - (i) Bottlehouse Street
 - (1) north side, from 12 metres west of Dobson Crescent westwards for 34 metres.
 - (2) south side, from 12 metres west of Dobson Crescent westwards for 65 metres,
 - (ii) **Dobson Crescent** east side, from Back St Peters Wharf northwards for 24 metres,
 - (iii) St Lawrence Road -
 - (1) north side, from 19 metres east of Glasshouse Street to 22.5 metres east of Dobson Crescent.
 - (2) south side, from 39 metres east of Glasshouse Street to 11.8 metres west of Dobson Crescent,
 - (b) revoke (remove) the existing prohibition of entry of any vehicle restriction from St Peters Quayside East (south of a point 52 metres south of The Moorings) into St Peters Quayside East (north of a point 52 metres south of The Moorings).
